



## Data Subject Access Request – MIAFTR

The Motor Insurers' Bureau (MIB) is the data controller for the Motor Insurers Anti-Fraud and Theft Register (MIAFTR) database, containing records of claims that have resulted in a written off or stolen vehicle. If you have made a claim which has resulted in a written off or stolen vehicle, a record may exist on the MIAFTR database.

Please note that only the insurer responsible for the data can amend the data. If any data is inaccurate, please contact the insurer or organisation who has entered the data onto the database. To check if a specific vehicle is listed as written off or stolen, you will need to carry out an independent Vehicle Provenance Check.
